19/00391/FUL - Erection of two-storey extension and porch to the rear. at 73 Oak Lane Kings Cliff

19/00487/TPO/ - T1 - Wych Elm (Ulmus glabra) - Fell due to the risk of catastrophic failure. The main stem has been colonised with Dryads Saddle (Polyporous squamosus), this has caused extensive decay resulting with less than 14.5% sound wood in measured areas. Should the tree fail at the point of decay it is highly likely a significant amount of harm would occur to person or property due to its location in a very confined area. at 2 Park Street Kings Cliffe
